CPR/AED Training and Certification Training and Certification Opportunity 2022-23

H (Host) The Office of Teacher Education and Licensure (OTEL) and the Purdue University Fire Department (PUFD) are offering CPR/AED training and certification for Purdue University Teacher Education undergraduate students that is credentialed, reliable, convenient, and cost effective. The training will be delivered in a 2-part, "blended" format, with the first portion of the training delivered online by the American Heart Association (AHA), and upon completion, a second in-person, hands-on training session conducted by the Purdue University Fire Department. CPR/AED training and eventual certification are requirements set forth by the Indiana Department of Education (IDOE) for all educators and Teacher Education candidates prior to licensure. E (Event) There are 11 in-person training sessions available <u>EACH semester</u> (see schedule below), with <u>EACH training session</u> having **nine (9)** available seats. ALL in-person training sessions will begin promptly at **5:00 pm EST** in the old State Farm Insurance campus, located at **2550 Northwestern Ave.** Students should park in the northwest parking lot off Kent Ave and enter using door #4 (see attached map). Inside the building will be signs leading to classroom **1200A**. If utilizing public transportation, use City Bus route 10, Northwestern to Yeager and Purdue, and exit at Beau Jardin Apts. on Yeager Rd (SE Corner), stop BUS100E (see attached bus route).

A (Attendance) Only nine (9) seats are available for each in-person, hands-on training. Should an emergency arise, out of courtesy for others on a waitlist, please cancel your in-person training following the instructions provided at the bottom of the <u>registration page</u>. Otherwise, once registered, your attendance is anticipated by the instructor.

R (Register) <u>TWO consecutive registrations</u> are required for training and certification. Plan to complete the second registration immediately following the first. The first registration is for the online portion of the training via the <u>AHA registration link</u>. The <u>second registration</u> is for the in-person, hands-on training session with the Purdue University Fire Department. The in-person training <u>cannot</u> be completed prior to the online training. Content/material from the online training session will be referenced and required to pass during the in-person training.

T (Total Cost) The only cost to Purdue University Teacher Education undergraduate students is the AHA online course, which is \$15.00 (paid directly online to AHA). The cost of the in-person, hands-on training and CPR/AED certification will be covered by the Purdue University, College of Education.
